International Archaeology, LLC (IA) engages in all aspects of cultural resource management, providing archaeological services that cover all aspects of planning, assessment, mitigation, a variety of in-house technical specialties, interpretation, and outreach. Clients include federal and state government agencies and private businesses and individuals throughout the Pacific Islands. Established in 2013, IA is wholly owned by, and shares all staff and offices with, the International Archaeological Research Institute, Inc. (IARII). Founded in 1986, IARII has established a well-respected record of scientific research that is documented by hundreds of technical reports and professional journal articles produced by staff members. Together, the companies have completed over 1,000 historic preservation and research projects of almost every size and type over a wide geographic region.

IA performs a broad range of cultural resources management services including archaeological surveys and assessments; data recovery and monitoring (including UXO sites); historical studies, preservation, and interpretive planning; National Register of Historic Places (NHRP) nominations; Geographic Information Systems (GIS) studies; oral history; and cultural impact assessments.

Our work experience includes archaeological reconnaissance and inventory surveys of various types (complete coverage, predictive modeling, sampling, etc.), test excavations, data recovery excavations, and archaeological monitoring. We specialize in performing background literature searches, assessments that include historical and archival research, preparation of mitigation plans (including data recovery, preservation, monitoring, and burial treatment plans), cultural resource management plans, and cultural resource assessments for Section 106 documentation, Environmental Assessments, and Environmental Impact Statements. Our staff is also experienced in preparing cultural impact assessments and interpretive planning projects for public education.

In-house specialized technical services include paleoenvironmental coring, bioarchaeological (osteological) and zooarchaeological analyses, macro-botanical analysis, chronological modeling, GIS services, drone photography, and photogrammetry. IA also has developed a wide network of affiliate archaeologists, expert consultants, and vendors with specializations that contribute to fulfilling our historic preservation goals.

IA employs experienced and highly qualified personnel and has the capacity to conduct multiple simultaneous projects involving a wide range of research, fieldwork, and writing skills. Many senior staff members have long histories of work experience in Pacific Island archaeology. This depth of experience accompanies a sensitivity and awareness of traditional values derived not only from formal research and investigations, but also from relationships with people and organizations in the community. One of the company's main objectives is the stewardship of cultural resources for future generations.
